The Commissioners were presented with copies of minutes from the meeting held July 20, 2023. A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to approve the minutes for July 20, 2023.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to rescind the offer of employment to Jazmin Clark as a Caseworker II in Children and Youth Services.

Received notice from the PA Department of Emergency Management informing the County they have completed their review of the County's combined report for the calendar year 2022 funding period.

Received a letter of resignation from Aging Care Manager Lauren Janusewski, effective August 11, 2023. A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to accept this letter.

New Business

The Commissioners held an employee anniversary recognition. The following County employees were in attendance:

Sheriff Chris Rosler introduced Sheriff Deputy Mark Santoli for his 15-year anniversary with the County. Sheriff Rosler said Mr. Santoli is the department's civil paper guru and he teaches new hires the ins and outs of civil papers. The Commissioners thanked Mr. Santoli for the role he plays in protecting county employees, buildings and the public. The Commissioners said he has always served as a good example to new deputies. Mr. Santoli said he hopes to be around for a few more years, though not another 15.

MIS Director Dennis Ford introduced Network Specialist Eric Swendsen for his 20-year anniversary with the County. Mr. Ford said Mr. Swendsen has really been with the County 22 years factoring in his internship. When Mr. Swendsen started, the IT department was a much simpler place. Mr. Ford said that as technology has progressed and grown, it has been great to have someone with his knowledge on staff. Commissioner Smith told Mr. Swendsen he has

always been a pleasure to be around, noting that he rode on his school bus. He said you have been a great asset to this County and we are glad you have been here for two decades. Commissioner Cramer said that she can only imagine how that department has changed over 20 years and is grateful for the team Mr. Ford has assembled and for Mr. Swendsen to make sure things ran as smoothly as possible. Commissioner Shook said that with the kinds of skills we have in our IT department, that group really runs the County. Mr. Swendsen said he appreciates the ability to be able to work here.

Domestic Relations Director Maryann Swingle introduced Enforcement Officer Katelin Dennis for her 1-year anniversary with the County. Ms. Swingle said that position can be a very difficult job, but also very rewarding. She said Ms. Dennis is a dependable worker, very eager to learn, and willing to help her colleagues when necessary. The Commissioners agreed it is not an easy job and noted that the 1-year mile stone is a very significant one and they hope she will be here as long as Mr. Santoli and Mr. Swendsen, who were recognized before her. They thanked Ms. Dennis for choosing a career here in Wayne County and told her they were grateful for the work she does. Ms. Dennis said her first year has gone by very fast and noted that everyone has created a supportive environment and she is thankful.

A motion was made by Commissioner Cramer, seconded by Commissioner Shook and unanimous to approve a letter of support for Via Transit in their efforts to have the Federal Highway Administration reconsider their interpretation of the Infrastructure Investment and Jobs Act's Rural Surface Transportation Grant Program in regards to On-Demand Transit Services.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to terminate Corrections Officer Warren Smith, effective July 25, 2023.

A motion was made by Commissioner Cramer, seconded by Commissioner Shook and unanimous to ratify the judicial termination of Domestic Relations Department Office Assistant Hope Swartz, effective July 25, 2023.

A motion was made by Commissioner Shook, seconded by Commissioner Cramer and unanimous to reclassify Rochelle Haviland as a Payroll/Retirement Specialist, effective July 31, 2023.

The Commissioners' meeting resumed.
