- To vote on a Ballot Question: Blacken the oval to the left of the word "Yes" to vote for the question. Blacken the oval to the left of the word "No" to vote against the question.
- If you make a mistake, do not erase it. Ask for a new ballot.
- Use a black or blue pen or pencil.
