December 30, 2022
Clinton Township Board of Supervisors Meeting

The year-end December meeting, was called to order by Vice Chair Brian Non on December 30, 2022 at 7:00 PM at the Clinton Township municipal building. Vice Chair Brian Non and Supervisor Brad Bates were in attendance. Chairman James Zefran attended by way of a video call.

- A. Pledge of Allegiance** - The Pledge of Allegiance was recited.
- B. Hearing Check** – The hearing check was done.
- C. Minutes of the December 13, 2022 Regular Monthly Meeting** – *Vice Chair Non made a motion, seconded by Chair Zefran to accept the minutes of the regular December 13, 2022 meeting. All voted yes. The motion carried.*
- D. Public Comment –Items on Agenda Only** – Ron Poska asked if anything was done for new truck financing. Chair Zefran said that we are good to go and will work on it after the first of the year.
- E. Appointment of Brad Bates as new Supervisor** – Vice Chair Non stated that Brad Bates had been appointed as Supervisor and would be serving out the remainder of the late Supervisor Russ Curtis’s term.
- F. Correspondence**
 - a. Letter from Wayne County Human Services Agency Housing Department asking of awareness of the unsheltered homeless count in Clinton Township. This preliminary information can be used to assist those experience a housing crisis in Wayne County.** – No one present was aware of any homelessness in Clinton Township.
- G. New Business**
 - a. The Clinton Township 2023 Reorganization Meeting is Tuesday, January 3, 2023 at 7:00 pm, followed immediately after by the regular January meeting. Clinton Township Auditors Reorganization meeting is Wednesday, January 4, 2023.** – Announced
- H. Treasurer’s Report Including Bills for Payment** - *Vice Chair Non made a motion, seconded by Chair Zefran to pay the bills as submitted on the bills list. All voted yes. The motion carried.*
- I. Old Business**
 - a. Resolution to Removing Light, Hose, and Storm Water Taxes** – **Vice Chair Non made a motion to pass Resolution 12-30-2022 to remove light, hose, and storm water taxes. All voted yes. The motion carried.**
- J. Public Comment** – Ron Poska, in response to the resolution expressed concern that the Browndale street light bill was roughly \$200 a month and that really adds up. Vice Chair Non said that the street lights are primarily on the main road which is a state road. PennDOT maintains and cinders that road. With that consideration, it’s a financial wash. Vice Chair Non said that Gavin on Long Pond Rd. expressed to him that there was no garbage pick up now due to the “No Winter Maintenance” edict. He asked Non if he could use the township dumpster until the issue was resolved. Non had given him approval to do so.
- K. Adjournment** –*Vice Chair Non made a motion, seconded by Chair Zefran to adjourn the meeting at 7:08 pm. All voted yes. The motion carried.*
