Clinton Township Board of Supervisors Meeting

The year-end December meeting was called to order by Vice Chair Non on December 30, 2021 at 7:08 PM. The meeting took place in the Clinton Township municipal building. Supervisor Curtis was also in attendance.

- A. **Pledge of Allegiance** – The Pledge of Allegiance was recited.
- B. **Hearing Check** – The hearing check was done. It was noted that the meeting was audio and video recorded.
- C. **Minutes of Regular Meeting December 8, 2021** – *Vice Chair Non made a motion, seconded by Supervisor Curtis to accept the regular meeting minutes of December 8, 2021. All voted yes. The motion carried.*
- D. **Public Comment – Items on Agenda Only** – No comments were made.
- E. **Correspondence**
 - a. **PSATS Members Conference Registration and hotel Reservation System opens January 11, 2022 for the PSATS 2022 Annual Educational Conference and Exhibit Show scheduled for April 24 – 27, 2022.**

 - b. **Email request from Jeremy Lamberti to hold a charity event to help first responders and injured veterans.** – Discussion was had regarding a road rally going from Route 296 to Cirelly Road, to South Smith Road, to Flat Rock Road on July 14 and 15, 2022. Vice Chair Non expressed concerns about eroding the dust control. Supervisor Curtis expressed a need for a road bond. Josh Debevec had concerns about safety and road damage. All voted yes. The motion carried. Joe Rossi was not hired.*
